Building for the Future at Grand View University

If you have noticed some vacant homes near the Grand View University east campus starting to disappear, way is being made for a \$15 million student housing project to address a recent housing shortage on campus. The former homes that are being demolished were owned by the school and have been a part of a long-term site plan.

Ground breaking for the first in a series of improvements at Grand View University is slated for this summer. The proposed four story, 232-bed, two- and four-bedroom student apartments will be located on the east side of East 14th Street, just south of Hull Avenue. Each apartment will have individual bedrooms with a shared kitchen and living room space. The apartments will be reserved for junior and senior students. Construction of the building is expected to be completed by fall 2011.

Larger than anticipated enrollment during the 2009-10 school year forced Grand View to place 27 students off campus at the Value Place, an extended stay hotel in Ankeny. Once the new apartments open, campus residences will have capacity for close to 800 students, about 250 more than this year.

The apartments are part of a larger improvement plan for campus. Also planned, is a 43,000 square-foot, two-story expansion to the Grand View Student Center at 2729 E. 14th St that will mirror the campus' Rasmussen Center building on the west side of East 14th Street. An enclosed pedestrian overpass to the Rasmussen Center is also planned. This part of the building project will not immediately be implemented.

Birdland Levee

Birdland Levee System Improvements project will be underway soon. Riverview Island will be the staging area and starting point for construction. The project includes degradation and reconstruction of a levee and floodwall system approximately 1.7 miles long with an approximate location of left de-

scending bank of the Des Moines River from McHenry and Riverview Parks (Oak Park Avenue & 9th Street) downstream to Birdland Park (vicinity of Guthrie Avenue and Saylor Road). This project is administered by the Corps of Engineers.

Construction will be done by 2012.

They have 480 days from start to finish to complete the project. The Corps of Engineers will return Riverview Island better than it was before, at their cost. Improvements to the Island will include grading, a bicycle path and plantings. It will tie McHenry Park in with Riverview.

Home and Garden Tour

It is with regret that the UPNA Neighborhood Home and Garden Tour has been cancelled for this year. In spite of the best efforts of the Home Tour Committee, not enough homes or gardens are available this year. We have several homes committed for next year, so expect the Tour to return in June 2011. The Home and Garden Tour showcases the wide variety of homes and gardens in the Union Park area and demonstrates the advantages of living in an established neighbor-

hood. Proceeds from the Tour benefits the Union Park Neighborhood Association's various projects. Homes and gardens are always needed for future tours. Consider having an open house event in conjunction with our Tour to celebrate a special event like the anniversary of your house being built, or to show off a new remodeling project. The homes on the tours do not need to be "perfect". In the past, we have heard that the most popular homes on home tours are the ones that are

"works in progress". If you have worked hard to design and grow a beautiful yard and garden, and would like others to see your efforts, this would be an opportunity to have other gardeners admire your gardening skills. Sewer Separation Project Planned

The City of Des Moines is currently designing a sanitary/storm sewer separation project that involves areas in the Capitol Park and Highland Park and Union Park neighborhoods, called the Lower Union Park Sewer Separation project.

This project provides for construction of a storm sewer in the Eastside Trunk Combined Sewer System to remove the remaining storm inlets from the combined sewer system in an area bounded by East Ovid on the north, University Avenue on the south, East 14th Street on the east, and Penn-

sylvania Avenue/Cornell Street on the west. A new sanitary sewer will also be constructed in East 12th Street to accommodate the sanitary sewer service connection currently connected to the combined sewer. This will separate the sewer system in this area. This area lies upstream of the existing combined sewer overflow at the Birdland Marina. This work is included in the Long Term Control Plan that has been developed to eliminate combined sewer overflows (CSO) as submitted to the Iowa Department of Natural Resources. A \$5,000,000 CDBG Jumpstart Grant has been

awarded for this project that will cover construction expenses, the City will be responsible to cover the costs for design and construction administration.

Soon bids for this work will be taken for this construction work but a start date has not been announced. As we learn more, will keep you posted on this project. Meanwhile if you have specific questions, contact Ron A. De Groot, P.E., Des Moines Public Works at (515) 323-8165.

City of Des Moines 2010 SCRUB

The Public Works Department, in cooperation with the Des Moines Neighbors and the Neighborhood Revitalization Board, has worked to schedule a number of SCRUB'S (Spring Cleanup to Remove Urban Blight) . This year, the Public Works Department will continue the use of the Metro Waste Authority (MWA) Transfer Station at 4198 Delaware Avenue and Metro Waste Authority (MWA) Compost Park at 1601 Harriett Street on seven Saturdays. Also see the following guidelines and complete SCRUB calendar or call the Public Works Department 24-hour Customer Service Center at 283-4950 or for more information go to www.dmgov.org.

Scrub Guidelines: Residents of Des Moines ONLY: Proof of Residency required; Photo ID or current utility bill.

Hours: Neighborhood SCRUB: 7 AM to Noon

MWA's Metro Transfer Station and the Metro Compost Center : 7 AM to 1 PM

Note: Metro Waste Authority's Metro Transfer Station and the Metro Compost Center are NOT open to the public, Except on Saturday SCRUB day events.

SCRUB Items Allowed: Trash containers, general trash including furniture, lawn mowers without fluids, TV's, computers, tires (any size, on or off rim),
Appliances: NO CHARGE THIS YEAR, air conditioners, refrigerators, freezers, microwaves, dehumidifiers, furnaces, stoves, washers, dryers, dishwashers, water heaters, etc.

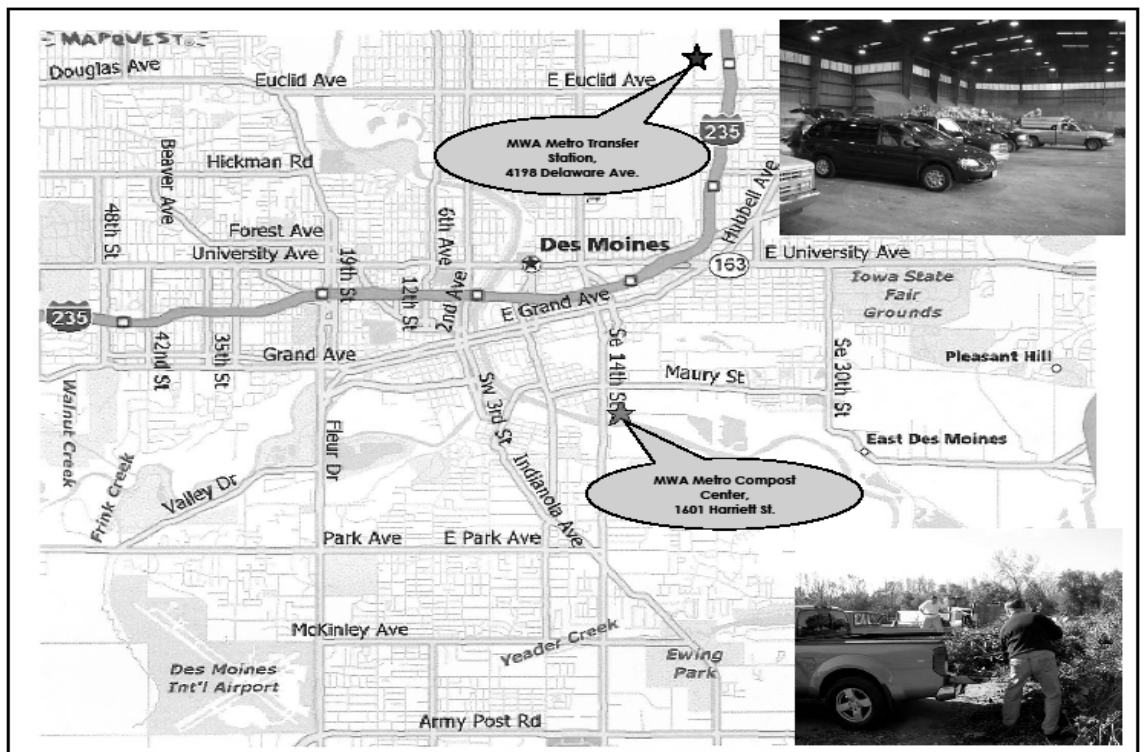
SCRUB Items Not Allowed: Car batteries, propane tanks, oil, paint or other toxic or hazardous chemicals. Call Metro Waste Authority's Regional Collection Center for Household Hazardous Waste at 967-5512 to dispose of these items.

All yard waste will need to be hauled to the MWA Metro Compost Center at 1601 Harriett ST. No yard waste accepted at neighborhood SCRUB sites.

Yard waste: Brush, tree limbs 24" diameter or less, maximum length 10 feet, prunings, loose leaves, loose grass clippings.

Grand View Student Newspaper Named Best Iowa Student Newspaper of 2009

The Grand Views, the weekly student newspaper at Grand View University, has been named the Iowa College Media Association’s Best Iowa Student Newspaper of 2009. This was the first year the organization named the state’s top newspaper for small colleges in Iowa. The Grand Views won the award based on its showing in the annual newspaper competition, which evaluates writing, photography and design. The other student newspapers in the top five were from Loras, Mount Mercy, Simpson and Wartburg. Senior Derek Hart is the 2009-2010 editor-in-chief of *The Grand Views*.

Grand Views staffers won 16 awards, including four firsts.

- News editor Stacey Campbell won first in the Best Sports Feature category for a profile of Grand View superfan Julius “Jules” Polich.
- Molly Hottle, who graduated this fall, was awarded first place in Best Feature Photo for a picture she took while touring Denmark with the Grand View Choir. Hottle also won a multimedia award for her blog she filed from Denmark.
- Photo editor Taylor Hinkle won two firsts, in Best Sports Photo and Best Photo Portfolio. He took his winning sports shot at the Iowa high school baseball tournament this summer at Principal Park. It ran in *The Grand Views* as a Photo of the Week.

Prevent Home Repair Scams and Disputes

Spring is here -- prime time for home improvement fraud and scams. We see it every year. Home repair needs pile up over the winter, and everyone is eager to make improvements. It's prime time to beware of scams and questionable contractors.

Home improvement fraud includes contractors who ask for substantial up-front payments, do little or no work, and never finish the job right. Other contractors offer a low price and then charge a lot more as the job progresses. Others are "fly-by-night" traveling con-artists working their roofing or paving or chimney-repair scams.

Follow these tips to avoid being taken by home repair scams and disputes:

1. Don't fall for the "knock-at-your-door" scam, where someone shows up "out of the blue" and says your driveway needs repaving, or your house needs new shingles – and they "just happen to have materials left over" at a big discount! They are sure to take your money and run, without doing the job at all or doing it right.

2. Check out contractors before you sign a contract or pay any money. Request local *references* -- and check them out. Contact the Attorney General's Office to see if it has *complaints* (call 515-281-5926, or 888-777-4590.) Contact the Better Business Bureau (515-243-8137, or www.bbb.org.) Check to see if a contractor has been sued by unsatisfied customers (or sued them) -- go to www.iowacourts.state.ia.us.

3. Get several written estimates, choose the best, and get a contract in writing. Before any work begins, agree on a *written contract* detailing work to be done, the price, who's responsible for permits, and any other terms. Ask for a copy of the contractor's liability insurance certificate. Put start and completion dates in writing, and consequences if the contractor fails to meet them. (Example: the contract could be nullified if the contractor doesn't start on time.) Note, if you sign a contract at a place other than the contractor's regular place of business – such as at your home – you usually have three business days to cancel the contract.

4. Avoid paying large sums in advance. If you need to make a partial advance payment for materials, make your check out to the supplier *and* the contractor. Insist on a "mechanic's lien waiver" in case the contractor fails to pay others for materials or labor.

5. Financing. It is usually a better deal and safer to obtain financing through your local bank or credit union, rather than a contractor. If you do arrange financing through the contractor and the papers are signed away from the contractor's place of business, you usually have three days to cancel the financing. The right to cancel the financing is separate from the right to cancel the home improvement contract.

Half Century Residence & Neighborhood Star Awards

How long have you lived in the same house or in Union Park Neighborhood? Iowans are known for their love of home and land. Two Programs, sponsored by the Union Park Neighborhood Association, will be recognizing neighborhood residents who have lived in the same house or neighborhood for fifty years or more.

The purpose of these programs are to call attention to and honor our neighborhood’s long-time residents. The living memory and the presence of these individuals in our neighborhood contribute a distinct sense of place to Union Park and a source of stability within a quickly changing world.

These are on-going programs, and applications can be submitted at any time. The Association will continue to present these awards at future General Meetings of the Association. **Eligibility Requirements: All applicants must meet all of the following eligibility requirements.**

For the Half Century Residence Award: The resident must have lived in one house continuously for 50 years in the Union Park Neighborhood.

For the Neighborhood Star Award: The resident must have lived continuously for 50 years in several houses in the Union Park Neighborhood

For the Silver Star Award: The resident must have lived in the same house in the Union Park Neighborhood that was occupied by his/her parents, grandparents, children or grandchildren for 50 years straight.

Applicant must reside at this house at the time of application.

House must be within UPNA boundaries, which are: The south side of Hull Ave. on the north, the railroad tracks on the east, the north side of Washington Ave. on the south, and the Des Moines River and the east side of Second Ave. on the west.

Absence for military service can be counted toward the fifty years if the resident returned to the same house

The purpose of these Awards are to recognize continuous residence. If you think special circumstances warrant an exception, please explain why.

Applicant need not be a member of the Union Park Neighborhood Association

Applicant’s signature, which is required, authorizes the publication of the applicant’s name in the Association’s newsletter.

All decisions of the Award Committee will be final.
