## Graffiti !

Any kind of graffiti should be reported immediately to the Graffiti Hotline at 237-1808. Citizens may report graffiti 24 hours at the hotline number. You are not required to give your name.

Graffiti is called the newspaper of street for gangs, used to mark territory and issue challenges to rival gangs. It is done by copy cats that are not gang related and it is sometimes considered "art" by the person doing it. All of it is vandalism and it is punishable if they are caught and many of them are, thanks to citizens. Graffiti of any kind

degrades the neighborhood and encourages violence.

Remember the "Four R's of Graffiti":

**Report it** - call the police and tell them where it is.

**Read it** - police will gather what intelligence they can from the graffiti. Convictions are often made by citizen's cooperation.

**Record it** - Police will take a picture of it for evidence. You may want to photograph it yourself to make sure.

**Remove it** - after the police have visited the site, and taken their own pictures of the graffiti, remove it. Often the only means to remove it is to cover it with paint.

Each of these steps is important, including the removal of the graffiti. Property owners are required to keep their property free of graffiti. When a problem is identified the owner is given a reasonable time period to clean the violation. If the graffiti is not clean it is done by the City and billed back to the property owner.

## City of Des Moines 2011 SCRUB

The Public Works Department, in cooperation with the Des Moines Neighbors and the Neighborhood Revitalization Board, has worked to schedule a number of SCRUB'S (Spring Cleanup to Remove Urban Blight). This year, the Public Works Department will continue the use of the Metro Waste Authority (MWA) Transfer Station at 4198 Delaware Avenue and Metro Waste Authority (MWA) Compost Park at 1601 Harriett Street on seven Saturdays. **Scrub Guidelines: Residents of Des Moines ONLY:** Proof of Residency required; Photo ID or current utility bill.

**Hours:** Neighborhood SCRUB: 7 AM to Noon

**MWA's Metro Transfer Station and the Metro Compost Center: 7 AM to 1 PM**

**Note:** Metro Waste Authority's Metro Transfer Station and the Metro Compost Center are NOT open to the public, **Except on Saturday SCRUB day events.**

**SCRUB Items Allowed:** Trash containers, general trash including furniture, lawn mowers without fluids, TV's, computers, tires (any size, on or off rim), Appliances: **NO CHARGE AGAIN THIS YEAR**, air conditioners, refrigerators, freezers, microwaves, dehumidifiers, furnaces, stoves, washers, dryers, dishwashers, water heaters, etc.

**SCRUB Items Not Allowed:** Car batteries, propane tanks, oil, paint or other toxic or hazardous chemicals. Call Metro Waste Authority's Regional Collection Center for Household Hazardous Waste at 967-5512 to dispose of these items.

**All yard waste will need to be hauled to the MWA Metro Compost Center at 1601 Harriett ST. No yard waste accepted at neighborhood SCRUB sites.**

**Yard waste:** Brush, tree limbs 24" diameter or less, maximum length 10 feet, prunings, loose leaves, loose grass clippings.

Greater Des Moines Habitat for Humanity will soon build four homes in the Union Park neighborhood! Our new neighbors will be located at: 2910 1<sup>st</sup> Street - 2333 E. 9<sup>th</sup> Street - 2410 E. 13<sup>th</sup> Street - 2612 Bowdoin.

The homes, all new construction, are set to begin construction in early Fall 2011. Three of the houses will be ranch-style and one will be a two-story. All of the locations were previously foreclosed properties that had become a blight on the community and will now help to revitalize the neighborhood.

Habitat for Humanity is not a giveaway program. In addition to a down payment and monthly mortgage payments, homeowners invest hundreds of hours of their own labor (sweat equity) into building their Habitat for Humanity house and the houses of others. Habitat for Humanity houses are sold to partner families at no profit and financed with a 20-year no-interest loan. The homeowners' monthly mortgage payments are used to build still more Habitat for Humanity houses.

In 2010, the Des Moines community partnered with Greater Des Moines Habitat for Humanity to build hope for 22 home-buyer families. In 2011 we plan to complete 25 homes, bringing the total Habitat homes to 168. ## Park and Recreation Department Update

Spring has finally arrived. Flowers are beginning to bloom and Union Park is becoming more active. Soon we will be planting the formal gardens with vibrant annuals and a collection of Dahlias. The area will be closed for a short time but will be ready for years of play after painting is complete along with the new surfacing which was installed last fall.

There are several activities to enjoy at Union Park this season: Heritage Carousel rides, a walk around the circle, playgrounds, picnic areas, flower gardens, open space, tennis, and mark your calendars for outdoor movies each Saturday night coming this September.

## Quik Trip

Quik Trip Corporation wants to expand its off-street parking at their store located at the intersection of East 14th and Guthrie. They own the adjacent property to the north which is zoned R1-60(residential) and want to add 9 parking spaces there. QT wants the new parking spaces to line up with existing parking, which places them less than the minimum required setback from East 14th. These issues require an exception granted by the Zoning Board of Adjustment which met April 27th to consider their appeal.

Union Park Neighborhood Association and 2 neighbors sent 'comment cards' to

the city, disapproving of QT's request. Reasons cited include excessive (delivery truck) noise (after hours), a drop in property values, concern that QT would use the expansion to add additional gas pumps in the future, better use of land along East 14th than gas stations; in short, a benefit for QT but not for our neighborhood.

Based on City Staff recommendations, regardless of neighbors' concerns, the Board passed the appeal, granting QT their request.

However on April 29th, City Staff discovered a 1998 ordinance that actually prohibits QT's expansion. This means

that QT will have to request a rezoning through the Plan & Zoning Commission and City Council before any expansion can occur. UPNA will be notified if and when QT submits a rezoning application for consideration.

The Union Park Neighborhood Association Steering Committee plans to invite a QT representative and concerned neighbors to an upcoming monthly meeting to discuss the situation. Monthly meetings are held the 2nd Tuesday at 7pm at the Humphrey Center, Rodholm Chapel - 2nd floor, Grand View University.

## Botanical Center

In the February newsletter we reported on the proposed changes to the Botanical Center. Since then the private group making the proposal has cleared several required steps:

Zoning Board of Adjustment approved the Center and surrounding land as eligible for Tax Increment Financing (TIF). Plan and Zoning Commission approved the closure of Robert Ray Drive from I-235 north to East 6th Street on April 7th. This includes closing the bike trailhead located under University Avenue at the "V" in the road. On April 25th the City Council approved to hear the "vacation and long-term lease, operation, management

and maintenance agreement of Des Moines Botanical Center and adjacent grounds including a portion of Robert Ray Drive to Greater Des Moines Botanical Garden" at the May 9th City Council meeting. This was included in the consent agenda with no public input.

It appears the city council and mayor plan to vote in favor of this on 5/9/11, clearing the way for the private group to begin their fundraising effort to transform the land, landscape and road closure. There has been little public comment, despite the fact that approximately 1400 vehicles per day use this road. An issue has been raised and may

be/ has been considered by Friends of the Botanical Center Board regarding opening the fenced-off gardens to the public periodically since the land is 'publicly owned'. No group has claimed responsibility for the approximate \$200,000 of current repairs needed for the existing Center. Tax dollars must fund it if the group's \$10,000,000 campaign does not include this expenditure.

There are many unanswered questions but it appears this proposal will happen....unless YOU have questions you are willing to ask City Council on Monday, May 9th. The meeting convenes at 4:30pm at City Hall.

## Bob Mahaffey, Citizen of the Year

The East Des Moines Chamber of Commerce recognized lifetime east-sider Bob Mahaffey as Citizen of the Year last February at their annual dinner and awards ceremony. We want to add our congratulations!

To us, Bob has been our hard working City Councilman for the past 8 years but more importantly he has been our long time friend. Among the projects he was cited for was his help in rebuilding of the east side after the summer floods we've experienced in the past few years as well as the East Village development, East High School's stadium renovation

and partnership with Grand View University and planning for a new clubhouse at the Grandview Golf Course. He continues to play an active role in the community, by serving on boards and commissions including the Grand View University board of trustees, Presbytery of Des Moines treasurer, Greater East Side Development Board, Bidwell Riverside board treasurer and the Des Moines Plan and Zoning Commission.

Actually this is the second time Bob has been awarded the Citizen of the Year by the East Des Moines Chamber

of Commerce. Bob first received the award in 1998.

Bob Mahaffey, 76, has worked at Anderson Erickson Dairy for more than 40 years, and is currently vice president of the east-side family dairy that employs over 575 workers.

## Saylor Road and Birdland Drive Update

As the Birdland Levee construction continues, Saylor Road was closed April 25<sup>th</sup> to allow the construction of a levee closure and reconstruction of a parking lot for the Birdland Shelter. The closure is expected to be a gate that can be closed when high water threatens. Saylor Road will remain closed for several months this summer. As a part of the project, UPNA was informed that it is necessary to remove a total of four large

trees – two on each side of Saylor Road in the project area. UPNA has been assured the tree removal will be “mitigated” by planting additional trees outside the clear zone of the levee after the projects are completed.

Birdland Drive has been closed as a result of the levee construction. Area residents are nervous if the Drive will re-open, however UPNA has been assured

by the Parks and Recreation Department that it is their desire to open it again to traffic and estimate an optimistic mid-summer target date. Weather and other factors affecting the levee construction could delay the re-opening of Birdland Drive. Birdland Drive is a Parks Department road, not a City street.

## We Have Lost a Great Friend

Long-time Union Park Neighborhood resident Margaret Swanson passed away March 16 at Taylor House Hospice in Des Moines at the age of 91. We celebrate her life.

Margaret was one of the founders of the Union Park Neighborhood Association. The first UPNA record we have is a set of minutes from the December 5, 1988 meeting. Margaret Swanson and Fred Gay were Co-Chairs. The name “Union Park Neighborhood Association” apparently was a temporary name, and they were discussing where the boundaries should be. Even though the group was just organized, they already were taking up tough questions

about zoning, used car lots, overgrown lawns, junk, and – Bill Ritchie’s favorite – planting trees.

By 1991, UPNA was a Designated Neighborhood. In 1993, the UPNA Action Plan was approved by the City and, in 1997, UPNA became a Chartered Neighborhood. Margaret Swanson was a guiding force that entire time.

Margaret always believed in our Union Park neighborhood and worked hard to improve it. She continued to attend UPNA meetings and support the goals and programs of the Association until about 2007, when she moved to Rose Glen from her salmon-colored Victorian home on Penn Avenue.

Margaret brought to the table her vast experience from serving on a multitude of civic boards and commissions over the years. She was a volunteer powerhouse and was described by the *Business Record* in 1999 as a “well-known and most beloved volunteer.” She was honored and praised for her work by many leaders, yet she was humble. She served because she loved doing it.

Her untiring advocacy for the neighborhood and the association, and her wise counsel when we faced controversial issues will be missed. She truly was an example of selfless service.



## Opening weekend May 14<sup>th</sup> & 15<sup>th</sup>!

The Heritage Carousel happily begins its 13<sup>th</sup> season this spring! The Carousel provided over 47,000 rides last year and is pleased to continue on with its mission of offering an affordable, wholesome and family oriented activity. The price of a child's ride continues to be just 50¢ and frequent opportunities for reduced or free events are worked into the season each year.

Revenue from animal adoptions, sponsored events and small & large group rentals continue to help keep a ride at its original price. Options now exist for small and large groups to use the Carousel for private rentals or for unlimited ride rentals during open hours. It is a favorite for birthday parties but also is utilized often by schools and non-profit organizations or gatherings, receptions for weddings and reunions and has become a unique spot for graduation, engagement and wedding photos!

The Rollin' Relics Car Club continues to be the largest annual contributor to the Carousel, having donated nearly \$20,000 from the "Cruise to the Carousel" for the past 10 years. These contributions have provided for bi-annual restorative painting of the animals (after this fall each animal will have been worked on and continued touch-up work as well as work on the crown and core of the Carousel will be pursued), and maintenance on the pavilion.

The Carousel enjoys the support from many "regular Carousel Kids" from the Union Park Neighborhood.
