# **Snow Priority Streets**

In 2010, Union Park was one of 16 neighborhood associations accepted into the Des Moines Public Work's "Snow Priority Streets" program. Signs were posted throughout the neighborhood designating the streets as "Snow Priority Streets". Under the program, the Snow Routes have the first priority for snow removal and treatment, and after that, the neighborhoods that are designated as "Snow Priority Streets" are next. Residents no longer have to wait until 4 inches of snow has fallen to have the streets cleared as in years past. Snow Priority Streets get plowed after every snowfall of an inch or more which results in a better job of snow removal to allow the sun and chemicals to do their job to make travel safer.

The Public Works Department will use

their fleet of "wing plows" to make two passes down a street instead of four. Because the wing plows are so big, they cannot be efficiently used on residential streets where vehicles are parked. The key to making this work is to enforce a parking ban on residential streets during snow events so they can clear roadways from curb to curb and minimize snow build-up on the street surface and the resulting icing conditions. That means that when snow removal operations are in progress, residents must move their cars off the streets to allow for snow removal. Residents will be given notice to move parked vehicles prior to ticketing, through the local media (TV, radio, Des Moines Register website), the City of Des Moines website, or by email notification to subscribers

(snow@dmgov.org). The parking ban is

enforced by the Des Moines Police Department by issuing a \$35 ticket for each violation. Once the plow has passed the cars can go back on the streets.

Des Moines is the only city in the Metro Area that does not have parking restrictions in residential areas during snow removal operations, other than designated Snow Routes. The Snow Ordinance has enjoyed widespread support from the 16 neighborhoods that participated in the program in 2011.

Twenty one (out of 58) neighborhoods now participate in the Snow Priority Streets program. The program will be offered to more neighborhoods in 2012.

## Jazz in July in Union Park

Union Park Neighborhood Association will host Jazz in July in Union Park on Sunday afternoon, July 8th from 2 - 4pm. Come hear live jazz under the shade trees near the East Shelter, located just west of Thompson Avenue and East 9th.

We will be seeking corporate sponsorship and we will announce the band that will be providing the entertainment. Typically, Union Park Neighborhood Association provides treats during the concert and we plan to have art exhibits and other exciting things going on during the concert. Bring your lawn chairs or blankets, the kids and dogs for a lovely afternoon in our beautiful park.

### **National BIKE PED**

The Des Moines Parks Department needs volunteers to participate in a National BIKE PED survey on May 15, 16, 17 and 19th and then September 11, 12, 13 and 15. The purpose of this event is to count and conduct surveys of bicyclist and pedestrian, to find out why people choose to walk or bike over drive, how far they are going, and the purpose for their trip in 26 locations throughout the City of Des Moines, with 1-2 volunteers per location.

By gathering this information the goal is to improve the quality of life in Des Moines through the increase of safe walking and bicycling as a viable means of transportation and physical activity.

This data will help understand how well facilities are meeting the needs of residents. It will also help with grant applications for funding new trails, sidewalks, and bike lanes. Volunteers must be 18 years or older or have a participating vol-

unteering adult with them and have good customer service skills when dealing with the public, volunteers and staff. Volunteers will attend a training session.

The Public Works Department, in cooperation with the Des Moines Neighbors and the Neighborhood Revitalization Board, has scheduled SCRUB days (Spring Cleanup to Remove Urban Blight). Continued will be the use of the Metro Waste Authority (MWA) Transfer Station at 4198 Delaware Avenue and Metro Waste Authority (MWA) Compost Park at 1601 Harriett Street on seven Saturdays. No shredders for personal documents have been scheduled this year.

#### **Scrub Guidelines:**

Residents of Des Moines ONLY: Proof of Residency required; Photo ID or current utility bill. MWA's Metro Transfer Station and the Metro Compost Center: 7 AM to 2 PM. Note: Metro Waste Authority's Metro Transfer Station and the Metro Compost Center are open to the public ONLY on Saturday SCRUB day events. See dates below.

**NEIGHBORHOOD MEGA SITES:** SCRUB day events in four Mega-Sites, located in four quadrants of the City, will be announced on the city website.

SCRUB Items Allowed: Trash containers, general trash including furniture, lawn mowers without fluids, TV's, computers, tires (any size, on or off rim), Appliances: NO CHARGE AGAIN THIS YEAR, air conditioners, refrigerators, freezers, microwaves, dehumidifiers, furnaces, stoves, washers, dryers, dishwashers, water heaters, etc. and this year e-waste such as computers.

HAZARDOUSE MATERIALS/WASTE: Metro Waste Authority's Regional Collection Center for Household Hazardous Waste will have a trailer at the Metro Transfer Station and at neighborhood Mega-Sites. There are certain things they will and will not accept. BICYCLES: Des Moines Bicycle Collective, a group that collects donated bicycles and refurbishes them to give to those in need will be on site to accept bikes that people want to throw away.

YARD WASTE: All yard waste must be taken to the MWA Metro Compost Center at 1601

Harriett ST. No yard waste accepted at neighborhood MEGA-SCRUB sites or at the Metro Transfer Station. Acceptable yard waste includes brush, tree limbs 24" diameter or less, maximum length 10 feet, prunings, loose leaves, loose grass clippings.

### **Boards and Commission Vacancies**

Marty Mauk, President of Des Moines Neighbors did some research and found that four of the seven members of the Zoning Board of Adjustment have not been reappointed when their term was up. Some members of the board have been expired since 2006. The Neighborhood Revitalization Board has 12 of the 16 members with expired terms. This is clearly against the city ordinance. It raises questions about the validity of

the board's decisions. It makes the board person whose term has expired less independent and more beholden to the Council person's wishes. These positions are filled by members of the City Council. Rather than seeking out new members of these boards, they keep reappointing, even though there are term limits on these positions. Although our Council members may complain that they can't find new people for these po-

sitions, it is evident that they have not made any real efforts to find qualified people. Marty suggested that the Council needs to look to the people who attend Des Moines Neighbors as a pool of candidates for these positions. Information is available on these vacancies on the City website, or contact your City Council person to express interest.

## **DMPD Meets With NBSD Neighborhoods**

The annual meeting of neighborhoods participating in the Neighborhood Based Service Delivery (NBSD) program took place November 10 at the Des Moines Police Academy. Representatives from almost all neighborhood associations were in attendance, including Carolyn Rogers, UPNA Correspondence Secretary, who attended on behalf of the Association.

This event provides an opportunity for key staff at the Des Moines Police Department (DMPD) to introduce themselves and update neighborhood representatives on programs and issues of interest. Neighborhood attendees also had an opportunity to share their concerns.

Sgt. Larina Blad, former Union Park/Oak Park/Highland Park NBSD officer, talked about the programs she has spear-headed to help area youth, including the Junior Police Explorer Program. This program targets middle-school children, introducing them to various police units and functions. Police officers become mentors and friends to the young participants. Other youth programs included Youth in the Parks, a five-day program to help clean up Des Moines parks, and opportunities to help those less fortunate, such as the homeless. The goal of these efforts is to keep kids actively engaged and off the streets.

In their opening remarks, Chief Judy Bradshaw and Maj. Stephen Waymire (who oversees Patrol) discussed the department's successes in reducing juvenile crime, partnering with faith-based leaders in the Community Ambassador Program (CAP), and controlling problems at the State Fair. Concerns about budget cuts were expressed throughout the meeting. Chief Bradshaw emphasized the importance of contacting elected officials with concerns – that citizen input is listened to. A packet was handed out showing budget and personnel changes in the DMPD 2008 – 2011.

DMPD receives approximately 250,000 calls for service per year. Detectives currently are following up on about 50,000 cases.

Maj. Dana Wingert presented the Pawn Automated System that has resulted in more than four times the amount of stolen goods being recovered. Licensed pawn shop owners now enter information electronically rather than filling out hand-written sheets.

Other programs of interest included the Crime Free Multi-Housing program, which now includes single rental houses and duplexes, and the Drug Disposal program for prescription and over-the-counter drugs.

The presenters continually emphasized the importance of communication and trust between neighbors and the DMPD. There are 58 recognized neighborhoods, 29 of which are covered "officially" by NBSD officers. Citizens are encouraged to contact their NBSD officers directly.

Each NBSD officer discussed criminal activity in his/her neighborhoods and noted any improvements or trends. Senior Police Officer Scott Baker, the newly-named NBSD officer for the Union/Oak/Highland Parks area, shared the following summary of offenses reported in the Union Park Neighborhood from Sept. 2010 – Oct. 2011: aggravated assault, 16; burglary, 91; larceny/theft offenses, 136; motor vehicle theft, 19; vandalism, 375.

The NBSD program was praised highly by all neighborhood leaders in attendance.

# **City Sidewalk Ordinance**

To help ensure that sidewalks are safe during the winter, City ordinance requires residents to remove snow and ice from sidewalks within 48 hours following the end of the snowfall. Property owners who do not comply are subject to a civil citation. A helpful hint for residents on snow routes – clear your sidewalk after the snowplows have finished

plowing to the curb. When you remove snow from your driveway or sidewalk, please remember that City ordinance prohibits placing snow on any public street, sidewalk, or right-of-way. Equipment operators often work 12 or more hours in a shift, and appreciate courteous and friendly drivers and pedestrians. Please help them to help you.

When shoveling out the mouth of your driveway, throw the snow to the right or left, but **NOT** in the street.

Residents who wish to report sidewalks not cleared of snow and ice accumulations may call 283-4950 and report the address of the sidewalk. You are not asked to identify yourself.

You may qualify if you made \$50,000 or less in 2011.

#### What to Bring:

Proof of identification

Social Security Cards for you, your spouse and dependents and/or a Social Security Number verification letter issued by the Social Security Administration

Birth dates for you, your spouse and dependents on the tax return

Current year's tax package if you received one

Wage and earning statement(s) Form W-2, W-2G, 1099-R, from all employers

Interest and dividend statements from banks (Forms 1099)

A copy of last year's Federal and State returns

Bank Routing Numbers and Account Numbers for Direct Deposit

is prudent to pick up delivered mail and
packages as soon as possible, to help
deter possible theft.


Free Movies in the Park – In the past, the Park and Recreation Department hosted free outdoor movies in Union Park on Saturday nights in September. The Steering Committee was informed by Park and Recreation that, due to budget cuts they would not longer do that. If we wanted to host a free movie (note singular) in Union Park in 2012, we would need to find a person to coordinate the event and pay a "donation" of \$300. We succeeded in finding a willing coordinator and talked Parks & Rec. into granting us two movies. We will announce more information when we know it. But it looks like we will have two movies in August or September.

Dog and Cat licenses - Wednesday, March 31 is the deadline to purchase vour City of Des Moines dog and cat licenses without a penalty. City ordinance requires all dogs and cats six months and older to have a license. The cost is \$15 for dogs and cats that are spayed or neutered, and \$35 for dogs and cats that are not spayed or neutered. Special rates are available for citizens over 65 years of age. The late fee is \$50 for each pet license. Applications are available on the city website at www.dmgov.org. Applications must be postmarked on March 31 or earlier to avoid the penalty. The City Clerk's Office is open from 8:00 AM to 5:00 PM daily, and will be open late, until 6:00 PM on Wednesday, March 31st to accept applications. The City Clerk's Office/ City Hall address is 400 Robert D. Ray Drive. Call the Clerk's Office at 283-4209 for more information.

Grand View University was recognized with one of three Post-Secondary Vision Awards at the Martin Luther King Scholarship Fund benefit banquet January 19 at Drake University. The acknowledgment is recognition for Grand View taking leadership in supporting the scholarship fund and for being a partner to secure scholarships for minority students in Iowa.

The Union Park Neighborhood Steering Committee will not sell calendars this year. The River View themed calendars sold well, but we ran out of material. In 2011, the calendars featured old post cards of Union Park and other Des Moines parks, but they did not sell well. All of our old calendars have sold out and we have no more in stock.
