Des Moines Historical Society Centennial Certificate Program

torical significance to Des Moines.

Better, Faster Snow Removal

New for the 2012/2013 snow season all residential streets will be plowed after 2 inch snowfalls. Streets will be cleared with larger snow plows known as "wing-plows".

Wing plows can clear a path 14 feet wide. This larger path requires vehicles to be off the street to make the equipment as efficient as possible. Therefore parking will be restricted until residential streets are plowed curb to curb.

Northeast Neighbors Inc.

Union Park Neighborhood Association is proud to participate in and support the efforts of Northeast Neighbors Inc. It is a consortium of neighborhood associations within the geographic area north to the Des Moines city limits, east to the Des Moines River and west to the Des Moines River.

Northeast Neighbors meets the third

Monday of every month at the East Side Library, 2559 Hubbell Ave and is chaired by Suzette Jensen.

The purpose of Northeast Neighbors Inc. is to share information of common interest and value, increase knowledge of neighborhood groups and associations located in northeast Des Moines and help them improve their neighborhoods. Northeast Neighbors Inc. promotes such commu-

nity efforts as forums, conferences and joint projects and advocates civic improvements and reforms for the benefit of the northeast area of Des Moines. Northeast Neighbors Inc. is not affiliated with another group called "Northeast Neighbors and Friends".

Polk County Water and Legacy Bond

On November 6th you will be asked to approve the Polk County Water and Legacy Bond. The Polk County Board of Supervisors unanimously referred a bond referendum to the November 6th, 2012, ballot in an amount not to exceed \$50 million for the purposes of acquisition and development of land for public parks, or other recreation or conservation purposes to be managed by the Polk County Conservation Board, including protecting the water quality of rivers, lakes, and streams, including the Des Moines and Raccoon Rivers and their tributaries, protecting drinking water sources, wildlife habitat, and natural areas, prevention of flooding, and construction

and improvement of trails and conservation facilities in Polk County.

A \$50 million bond referendum spread out over 20 years would fund acquisitions to protect sensitive areas, connect greenways, improve water quality, and reduce flooding in Polk County. It would also enhance accessible outdoor recreation, conservation education, and complete trail connections that would connect communities and encourage healthy lifestyles. It would cost the average household in Polk County less than \$10 per year if all bonds were issued immediately based on current rates.

The use of these funds would be

executed and guided by existing master plans and capital improvement plans of the Polk County Conservation Board. All expenditures will be subject to public review to assure that funds are used wisely and public benefits are maximized. As with current funds made available to the Conservation Board, these funds will be leveraged with other communities and local agencies, continuing partnerships to enhance and protect the natural environment.

It is estimated that the contractor was expected to start the work starting after August 21 when the wading pool closes. This is according to Richard Brown, City Park Planner.

Wheeler (who owns Highland Park Hardware) has organized the event for many years, but this year he turned it over to his daughter, Felisa (Phyllis) Wheeler. Felisa did a great job this year. She said she "hopes to see everyone again in another couple months when we will begin preparing for CORN FEED 2013!"

National Night Out this year was a great success! It was August 7th. The Union Park United Methodist Church invited Union Park Neighborhood residents to join them and get out of the house and meet other neighbors and celebrate an evening of food and fun. There was a cookout with plenty of delicious food and drinks. The games were a big hit with the kids and a train to provide rides for kids (of all ages) around the parking lot. They even has D.J. playing upbeat music. The turnout from the neighborhood this year was better than ever before. Representatives from the Fire and Police departments were there. A fire truck was opened up for people to climb on. There were prizes and bracelets and bears. National Night Out occurs every year in August and it helps encourage neighbors to build camaraderie and discourages the criminal element.
